## What's lucky about a four-leaf clover?

With St. Patrick's Day coming on Monday, March 17, four-leaf clovers are popping up everywhere.

But how did they get associated with luck, and for that matter, with St. Patrick's Day?

First off, you're lucky to find one. Only 1 in 10,000 white clovers (*Trifolium repens*) has the mystical fourth leaf, caused by a recessive gene. *Trifolium* means "three-leaf" in Latin.

Saint Patrick used the three-leaf clover (called a shamrock, from Irish seamróg) to explain the Holy Trinity.

The connection to St. Paddy comes from a mash-up of shamrocks, Irish magic lore (think leprechauns), and the luck of finding a four-leaf clover.



Ever notice how clutter sneaks up on us? We accumulate things so gradually that we hardly notice. Something new comes in, nothing old goes out, and before we know it, we're drowning in stuff we don't need.

#### Should you put your money into a mortgage or into retirement?

The short answer is that it's not a good idea to minimize retirement savings to buy a house. But it really depends on a lot of factors. Here's one example: Let's say you're a couple in your 50's with about \$195,000 in retirement savings and earning \$125,000/yr. You want to buy a house, leading to a new \$3,100/mo. mortgage. You'd pay for that by reducing your retirement contributions. Is it a good idea? Most financial planners would probably say no, for the following reason:



• Using the popular 4% rule for withdrawing from your retirement accounts, a \$195,000 nest egg gives you about \$7,800/yr., plus your government pension of around \$23,000/yr., you end up with \$30,800/yr. for retirement. Yikes! You should be putting more, not less, into your retirement.

But having a house gives you options, too. You can sell it if needed. You can age in place. You don't have to worry about a landlord. You have something to pass on to the kids. So, what should you do?

You have a few options. You can boost your income through a side hustle, new job, or raise. You can look for a more affordable home. You could buy a property with a rental unit—tenants don't have to be permanent.

The goal is to retire without the fear of losing your home. Paying too much for a mortgage instead of saving may leave you house-rich but retirement-cash poor, with your money tied up in property instead of savings. But as said at the outset, there are numerous factors involved.

### Save the red wine for drinking!

A goblet of red wine is like five ounces of red dye in a glass. When it spills on carpet, you need to act fast — like the night before an open house, when we were celebrating, and Mr. Seller spilled his glass of pinot. His wife started scrubbing frantically at the spot, at which point I jumped in with a bit of knowledge I'd learned from a carpet cleaner.

First, you don't ever want to scrub a wine stain; it only sets it in. Instead, we blotted the stain from the outside in. Then we poured salt on the 'wound' to soak up the liquid, vacuumed, and repeated. We also poured a little heated club soda over the spot, then blotted and salted again. By morning, the stain was nearly invisible — likely saving them a \$5,000 carpet allowance! Other stainfighting tricks include oxy-based cleaners, hydrogen peroxide mixed with dish soap, or vinegar and dish soap.
